Justification for Real World Testing Approach

The Real World Testing Approach will include querying log data to determine the usage of the feature associated with each criteria being tested. For features that generate any type of output, including exports, testing will also include identifying if the output was created and delivered successfully or if any errors were logged. Epividian will report the usage and completion results in the Real World Test Plan Results report.

It is recognized that not all customers will use all features. If it is determined that no customers have utilized a feature associated with a criteria being tested, Epividian will utilize test user account(s) in the CHORUS environment(s) of client(s) that encompass all care settings and run the feature to ensure expected results are received. Epividian will report the outcome of the test run, including successful creation and delivery of any output, in the Real World Test Plan Results report.

Test Plan (b)(10) Electronic Health Information Export

Description of Measurement/Metric	The tester will query CHORUS log data to determine the number of times a user used the Electronic Health Information (EHI) Export feature. The tester will confirm that the EHI Export feature was used only by authorized users and each use successfully generated and delivered files to the user.
Relied Upon Software	N/A
Justification for Measurement/Metric	Epividian will report the number of EHI Exports generated across all clients. This will include a count of uses of the feature across all clients, confirmation that all uses were by an authorized user, a count of successful exports, and a count of export requests that resulted in failure or error. It is recognized that not all customers will use this feature. If it is determined that no customers use the EHI Export feature, then Epividian will utilize test user account(s) to access the CHORUS environment(s) of client(s) that encompass all care settings and run the feature to ensure only authorized accounts are able to use the feature and the export is successfully created and delivered. This approach is intended to demonstrate the real-world volume of exports processed.
Expected Outcomes	Electronic Health Information Export CSV files are successfully requested and generated by any user with the required authorization. CSV files and hyperlink to the export's format are delivered in encrypted, password protected, compressed ZIP format. Error rates will be tracked and trended over time.
